The Panel Lawyers shall be paid fee/honorarium as per the Schedule of the Tripura State Legal Services Authority Regulations, 1998 on submission of bill supported by the copies of Memo. of Appointment issued by the HCLSC and the Order/Judgment passed by the Hon'ble High Court in the related case within 02(two) months positively from the date of disposal of the case as well as ending of working month as the case may be. Each and every legal aid case dealt by Panel lawyers, must be updated regularly in the LSMS postal, otherwise, payment will not be released for such cases.
2. The Panel Lawyers shall intimate the Secretary to the High Court Legal Services Committee, High Court of Tripura about the case number, date of filing, position of the case etc. soon after the case is filed in the Hon'ble High Court on behalf of the Legal Aid Beneficiary.
3. The Panel Lawyers shall inform the development of case(s)/assignment(s), lying pending with him/her, to the Secretary to the High Court Legal Services Committee, High Court of Tripura **on monthly basis** for evaluation of his/ her performance in respect of each and every assigned legal aid case.
4. The Panel Lawyers shall render their services for legal aid, as and when called for.
5. If a Panel Lawyer is found to be guilty of misconduct or violates any of the provisions of the National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010; and/or the Tripura State Legal Services Authority Rules, 1998, he or she shall be liable to be removed from the Panel besides any appropriate legal proceedings.
