NOTIFICATION

This is issued in modification of the earlier Notification No. F.44 (11) HC/2016/ 497, dated 09.01.2017 with regard to paragraph no. 2 & 6.

Revised Guidelines:

Paragraphs:

2. (i) In the cases where no income proof of the injured/ deceased issued by the competent authority is submitted, notional wages for determination of compensation in the claim cases/appeals involving accidents which had taken place on or before 31.12.2015 shall be as follows:

- (ii) In the cases, as in the preceding paragraph, notional wages in the claim cases/appeals involving accidents which had taken place after 31.12.2015 shall be follows:

- (iii) Determination of the percentage of income towards future prospect in addition to such notional / actual income shall be made in terms of the ratio decided by the Hon'ble Supreme Court in **Sarla Verma (Smt) & Others Vs. Delhi Transport Corporation and Another**

6. (1) Under the head of 'Pain & Agony' for non-scheduled injuries, the amount of compensation should be as follows:
- (i) Simple fracture : Rs.50,000/-

(ii)	Comminuted Fracture	: Rs. 80,000/-
(iii)	Additional independent fracture	: Rs. 10,000/-
(iv)	For Loss of tooth or injury to tooth or any phalanges	
	a)	Per tooth : Rs. 15,000/-
	b)	Metacarpals/metatarsals : Rs.40,000/-
(v)	Fracture of rib	
	a)	Hairline or single rib fracture : Rs. 20,000/-
	b)	Multiple fracture : Rs. 70,000/-
(vi)	Fracture of collar bone	: Rs.20,000/-
(vii)	Injury or fracture of kneecap/patella	
	(ii)	Not requiring operation : Rs. 30,000/-
	(iii)	Requiring operation : Rs. 80,000/-
(viii)	Fracture of any other joint not covered above	: Rs. 40,000/-
(ix)	Cerebral concussion, without disability	: Rs. 20,000/-
(x)	Skull fracture, without disability	: Rs. 40,000/-
(xi)	Head injury with hematoma	: Rs. 40,000/-
(xii)	Vertebra injury, without disability	: Rs. 40,000/-
(xiii)	Nasal bone	: Rs. 15,000/-
(xiv)	Facial bone fracture (maxilla/zygomatic/mandible)	: Rs. 40,000/-

(2) The amount of compensation, as above, shall be in addition to the actual expenditure incurred by the injured claimant for his / her treatment.

This order shall come into force with immediate effect.
